





Getting Started - Quick Start


1 Enable the Stripe Integration in Street.co.uk



- 1 Go to Settings > Integrations > Stripe
- 2 On the Configuration tab, click Get Started
- 3 You'll be redirected to Stripe's onboarding flow
- 4 Complete the setup in Stripe, once done, your Stripe account will show as Connected in Street.co.uk



2 Configure VAT Settings in Stripe



- 1 In Stripe, go to the left-hand menu and click More
- 2 Select Tax > navigate to the Registrations tab.
- 3 Click Add Registration at the top:
 - Choose United Kingdom (UK)
 - Select "I've already registered" > No
 - Click Start collecting
- 4 Go to Settings (cog top right) > Billing > Invoices tab
- 5 Scroll down to Invoice tax information
 - Under ID Type, choose GB VAT
 - Enter your VAT ID number
 - Click Save

3 Set Up AML Charges in Street.co.uk




- 1 Go to Company Settings > Consumer Payments.
- 2 Enter the amount you'd like to charge buyers for AML checks.
- 3 This charge applies to the full buyer/applicant party, **not per individual**.
- 4 Click Save

If you have multiple branches, go to Branch Settings to set branchspecific charges.

4 Request Payment from a Buyer



- 1 Open a Sales Applicant page
- 2 Click the new Request Payment button
- 3 An email is sent to the buyer(s) with a link to pay via the Street.co.uk client platform


5 Monitor Payment Status



Once payment is made:

- You'll receive a notification
- The applicant card updates with a Paid status
- A payment receipt link will also appear on the card

6 Track Payments in Reports




- 1 Navigate to Reports > Payments Overview to view:
 - Payments requested
 - Payments received

You can also access detailed reporting directly from your Stripe dashboard

Can I charge clients for other services?

Not yet, buyer charges are available now. Seller and other service charges will follow.

Will payments be automatically requested?

No, you must manually click the Request Payment button for each applicant. Automation may be added later.

When does my agency receive the money?

At the end of each month, Stripe will send you a payout.

Are there any fees?

Street.co.uk fee: Stripe fee:

£1.90 per transaction UK cards: 1.5% + 20p

EU cards: 2.5% + 20p
